Happy New Year! I hope 2024 will be a wonderful year for you and your loved ones.

We have included our annual questionnaire on light blue paper behind this letter. We appreciate you taking a few minutes to review and carefully complete all applicable areas on both sides. This questionnaire provides essential information to ensure we prepare a complete and accurate tax return for you. It is our best way of knowing if your tax profile has changed from last year or if there are any new items we need to consider for your situation. If you answer "yes" to any of the questions, there is likely information you need to provide us.

There are two questions you will see in this letter for more information.

- Question 2 for all taxpayers We are offering an optional new service this year for individual taxpayers. Over the last few years, we have experienced increased compliance audits from IRS and states' Departments of Revenue. The resolution to these letter inquiries and audits can be costly, on an hourly rate basis. If your 2023 federal or state income tax return should come under inquiry or audit, our company will represent you up to and including the appeals level. There are two options for covering the cost for the additional time required. If you elect this service, you will be billed 20% of your 2023 tax return preparation fee when the return is finalized. We will handle all correspondence or audit meetings relating to your 2023 federal or state income tax return on your behalf. Or, if you choose not to participate in this new service, we will continue to review and work with you on any inquiry letters received at our standard hourly rate. Either way, we are most grateful for the opportunity to be of service to you.
- Question 2 for taxpayers with an LLC or Corporation Current regulations indicate that starting in 2024, the Corporate Transparency Act ("CTA") mandates certain entities (primarily small and medium-sized businesses) created in or registered to do business in the United States report information about their beneficial owners (the individuals who ultimately own or control a company) to the Financial Crimes Enforcement Network ("FinCEN"). Your company's management is responsible for your compliance with the CTA, if applicable to your business, and for ensuring that any required reporting is filed with FinCEN on time as required by the CTA. This is a legal reporting issue akin to forming an entity or renewing the entity's status with the Secretary of State each year. Since our firm does not offer any legal services, we will not be responsible for advising you regarding the legal or regulatory aspects of your company's compliance with CTA, nor are we responsible for preparing or submitting your information to FinCEN. You can visit fincen.gov/boi-faqs for further details. If you have additional questions, including but not limited to your company's legal filing requirement, I strongly encourage you to consult with legal counsel qualified in this area. While I cannot offer further assistance with this filing, I want to make sure you are aware of this, as there are very stiff penalties for failure to comply.

We appreciate when you gather all information (other than late arriving K1 forms) for your tax return preparation.

Providing all information at once helps us efficiently, accurately, and timely prepare your return at a savings to you.
